President's Report

As we close 2021 and look forward to 2022, the Club is grateful for the continued support from the entire membership. We have been extremely fortunate to have received unwavering support from our membership over the past two years.

With our solid membership base and our dedicated management team, we have returned to normal activities at the Club. We continue to take precautions and your safety remains a continuing concern; however, I believe golf remains a safe and enjoyable activity during these trying times. All that said, I am keenly aware that many of you were unable to enjoy all the clubhouse activities over the past year because of pandemic-related restrictions or concerns. I want to express my appreciation for your continued support of your Club.

During 2021, we gained 21 new members, bringing our total social and corporate membership to 344. We continue to promote Club membership amongst our wider communities, but we rely on you, our members, as you provide our best referrals and prospective members. Please continue to refer your friends, family, and acquaintances to the Club.

We continue to make regular and measured investments to our course and clubhouse. Over the past year, a large portion of the driveway was replaced. We anticipate replacing the remaining driveway this spring. Additionally, the patio was expanded to allow additional tables for outdoor dining. The cart path on the west side of the clubhouse was widened.

A major capital investment was updating the water line from the new sewer plant being built north of town. Currently the club is allowed to pump effluent-treated water from the current sewer plant, which is adjacent to the course for our irrigation needs. This endless supply of water allows our turf team to maintain a lush green course while other courses struggle with either lack of water from their water sources such as ponds or reduce their water usage because of the high cost to purchase adequate water supply. As a Club, we are fortunate the city of Indianola worked with us closely to ensure the new water line was feasible. They also assisted with the financing in the form of a long-term note, at a very reasonable interest rate, to make it affordable for the membership. I would like to thank the City of Indianola for their cooperation as they understand the value the Club brings to our community.

Budgeting for capital expenditures remains a priority of the board. The board maintains both a long- and short-term budget for capital expenditures. I am happy to report that much has been accomplished over the past few years in the form of upgrades and maintenance to both the course and facilities. Mike Coppess will provide a financial summary below; however, I am happy to report that the loan for the development of the west nine addition is scheduled to be paid off in 2024. The timely retirement of this debt, along with the major upgrades, positions the Club for a healthy financial future.

Our achievements during 2021 would have been impossible without the efforts of our outstanding staff, both full and part-time. I would like to thank Jason, Joe, Jennifer, and Nick for their dedication to our membership and the success of our

Club. They worked together as a team and remained flexible, while ensuring our members received a quality experience.

Thank you for the opportunity to serve you as your Club President. I know I don't need to remind everyone; however, we have a wonderful Club and are fortunate to have the opportunity to enjoy the services it provides. The board understands that golf is a discretionary option, and we truly appreciate your continued support. Thank you, again, for your support over the past year and we look forward to another great season of golf in 2022.

Indianola Country Club 2021 Financial Update

The board of directors is pleased to report that Indianola Country Club is in a solid financial position and the club continues to use your dues, fees, and purchases for capital improvements to enhance the clubhouse and golf course, upgrade equipment and pay-down long-term debt. The most obvious improvement during 2021 was repaving a portion of the entrance drive. No one recalls when the driveway was installed, but we are optimistic the new drive will serve our members and guests for the next 40 years. The remainder of the driveway is scheduled for replacement in the spring of 2022. The clubhouse patio and west sidewalk was also replaced, resolving the hazard of an uneven surface, and expanding to provide more room for outside entertainment.

ICC acquired \$29,000 of new golf course equipment during 2021. The most recent addition was an aerator at a cost of \$25,000 which allows Joe and his crew to open small holes deep into the greens. This provides a rapid recovery and saves the club \$2500 each time it is used as we no longer need to hire a 3rd party to complete this task; ICC will benefit from this purchase for many years.

Twenty years ago, ICC borrowed \$1,000,000 to build the west 9 holes and there remains a balance of approximately \$175,000 on this loan. ICC is on track to make the final payment in March 2024 and the mortgage on the golf course will be paidin-full. While this will be a huge milestone, in 2021 ICC entered into an agreement with the City of Indianola to finance \$355,000 for the waterline to pipe effluent water (used for irrigation) from the city's new sewer plant to the golf course. Without this pipeline, ICC would have been forced to cut back on the amount of water applied to the course or pay market rate for city water. To assure ICC has adequate water at an affordable cost, the city financed our loan at 2% fixed rate for 10 years and beginning in July 2022 ICC will pay the city approximately \$40,000 each year until July 2031. The City of Indianola has always been supportive of ICC; this is one more example of how our city leaders recognize the value ICC brings to our community.

COVID has changed the world and the way we work and play. As families and individuals sought ways to remain active without close personal contact, the sport of golf has become quite popular. ICC has increased family and individual golf memberships from 282 on October 1, 2019, to 325 as of October 1, 2021. From a financial perspective the club has benefitted as these new memberships contribute additional cash flow to pay for operating expenses and capital improvements. Your board and staff will continue to seek ways to apply these funds to improve our club and enhance your golf experience, while building on the long-term financial strength necessary to sustain ICC for future generations.
