#### **Culvert on Hole 10**

The culvert on Hole 10 fairway is caving in. It is sink-holing because it has rusted away on the bottom of the pipe. This pipe was implemented approximately 20 years ago.

Discussed the following options:

- Line existing pipe
- Purchase and install a new pipe
- Remove the pipe and allow the creek to flow
- Use bentonite to fill holes. (not recommended until we know future plan).

Joe will paint white lines to outline the hole. Requested board members to review hole to see how allowing the creek to flow will change play.

### Condition of Country Club creeks with new home development

Question was posed about the condition of the Country Club creeks as new developments are built. Joe feels confident in engineering, and we have a retention pond behind hole number 3. Also notes there will be an additional retention pond. New developments are not currently using Country Club pond for water retention.

#### Question posed regarding waiving maximum paid rounds for prospective members on waiting list
